- Include model policies, DPIA (Data Protection Impact Assessment) templates, and algorithmic risk classification tools.
- Build a repository of mappings from legislative requirements (EU AI Act, DSA, etc.) to technical implementation guidance (e.g., documentation, model cards, data sheets, logs).

Multi-Stakeholder Dialogue Workshops

- Run targeted workshops with regulators, tech developers, civil society, and end-users to test proposed compliance frameworks and codes of practice.
- Facilitate participatory design of AI use-case scenarios to understand sector-specific risk implications.

AI Compliance Pilot Testing

- Partner with SMEs, NGOs or public sector entities to implement and test the governance frameworks and codes in real-world use cases.
- Create a “sandbox” environment to simulate legal obligations under the EU AI Act and assess their operational viability.
